- His supervisor thinks he has a part time job at a marina in Reedsport.
- His duties include making rounds in an FS vehicle picking up trash, cleaning campgrounds and bathrooms.
- WHITE currently lives at the Siltcoos WC in his newer RV, I believe Class B, and has a newer model red Jeep Rubicon with KY plates.
- Christina Ojeda is an FS Employee and WHITE's current supervisor. Christina # 541-999-1838. She was told not to advise WHITE that FS LE was inquiring about his whereabouts.
- Attached are two screenshots of the Siltcoos Workcenter location, about 10 minutes south of Florence. It's the first left after you turn off HWY 101 that has do not enter and FS Only signs. The gate is sometimes closed and secured with a Yale Lock.

If for some reason I'm not able to accompany you, you can either just walk the 50 feet past the gate or call Christina for access.

I would have gotten you some current pictures but my schedule last week was tight. Shoot me a text or call Monday to confirm for Tuesday.
